Appendix I

Authority for Execution of Mission Essential Tasks

During Phase 1 of the *USACE 2012 - Future Corporate and HQ Design Study*, the Study Team realized that it would be important to identify the duplication of functions within HQUSACE and MSC offices. This resulted in the preparation of a matrix identifying specific functions identified by each major organizational element of HQUSACE and MSCs. The matrix was based on the MSC structure with the MSC Civil Works and Management Directorate and Military and Technical Directorate being evaluated to the Division level of detail. The HQUSACE functions were then applied against the disaggregated MSC functions. Published Missions and Functions Statements as included in OM 10-1-1 (or appropriate MSC regulation designation) provided the basis for information included in the matrix.

As Phase 2 of the study began, it was further realized that prior to recommending structural, mission, and/or functional changes, the team should be aware of the impacts of any recommended changes that are based in statute and/or regulation as well as the possible need for revision of existing statutes or regulations. To accomplish this task, the assistance of the Office of Chief Counsel was requested.

The Office of Chief Counsel's task was to identify the laws and regulations, if any, that require HQUSACE and/or MSCs to perform specific functions. In completing this assignment, three parameters were established. First, recognizing that all of the functions listed are authorized by statute or regulation, research was limited to statutes and regulations that direct or require a function to be performed. Second, the research focused solely on those statutes and regulations that require USACE or the Chief of Engineers – as opposed to Federal agencies, in general – to perform a function. For example, 5 U.S.C. ¶ 7201 directs executive agencies to conduct affirmative action programs for the recruitment of minorities pursuant to regulations promulgated by the Office of Personnel Management (OPM); the Army (an executive agency) in turn issued AR 690-12 requiring Major Command (MACOM) commanders to implement affirmative action programs. Since the statute itself was directed to all executive agencies and not specifically to the Corps, it was not included in the report. Third, the research was limited to statutes and regulations and did not include other directives, policies, or guidance such as Engineer Circulars and Pamphlets, Command Directives and Guidance, and Commander's Policy Memoranda.

The results of the research by the Office of Chief Counsel are shown on Exhibit I-1. The matrix identifies the missions and functions performed by the major functional elements of HQUSACE and the MSCs (left column) followed by the laws and regulations that require performance of that function with information disaggregated between HQUSACE and MSC offices. The columns labeled "statutes" contain citations to the U.S. Code or Public Law numbers of statutes that direct USACE or the Chief of Engineers to perform the function. The columns labeled "USACE" list regulations issued by the Corps of Engineers, e.g.

Engineer Regulations (ERs) or USACE Supplements to Army Regulations that require the function to be carried out. The columns labeled "OTHER" list citations to regulations issued by the Department of Defense, Army, or other federal agencies, such as the Code of Federal Regulations or Army Regulations (ARs), that require HQUSACE and/or MSCs to perform the function. Where no applicable statutes or regulations were found for a specific function at both the HQUSACE and MSC level, the function has not been shown on the matrix.

Analysis of the statutory and regulatory authorities for the execution of HQUSACE and MSC mission essential tasks reveals the following:

The majority of functions listed in Appendix I are not directed or required to be performed by statute at the HQ level. The major exceptions are for certain Civil Works functions and, to a lesser extent, certain Military Programs and Resource Management functions.

None of the functions listed are directed or required to be performed by statute at the MSC level.

The majority of HQUSACE and MSC functions are required by regulation (i.e., Army Regulation or Engineering Regulation).

Conclusion: With the exception of the specific Civil Works, Military Programs, and Resource Management functions identified on the matrix, there are no statutory constraints to effecting functional and/or structural changes to achieve the ideal future Headquarters design. Most HQUSACE and MSC functions appear to be based on regulatory requirements which, at least in principle, are subject to revision where necessary. In many cases, however, revisions would be required at the DA level.
